Dear Mr. Meader,

Prior to commencing completion operations on the CC16 SW Pad, the Colorado Oil and Gas Conservation Commission ("COGCC") is requiring HighPoint Operating Corporation (HPOC) to re-plug the Nauta #1 Well (API No. 05-123-07135) (the "Well"). The Well was previously abandoned by Todd Gross in 1970 and is located on surface owned by you according to applicable records. The COGCC policy requires HPOC to obtain the consent of the surface owner for the operation either through the existence of a surface use agreement or a specific consent if there is not an applicable surface use agreement. In the case of the Well, there is no applicable surface use agreement. Therefore, HPOC is requesting your written consent to the re-plugging operation for the Well.

In addition and pursuant to rules 305.f.(4) and 305 f. (6) of the COGCC rules governing subsequent operations well operations, HPOC hereby gives its seven (7) day notice before use of heavy equipment about the re-plugging operation for the Well and its thirty (30) day notice of final reclamation operations to follow the re-plugging and abandonment of the Well.

Once the re-plugging operation commences, HPOC's contractor should be on location for approximately 5-10 days, weather permitting. If you request, a representative from HPOC will be available to meet and consult with you about the re-plugging operation. If you prefer, you can appoint an agent by providing HPOC with the name, address and phone number of the agent.

If you elect not to consent to the re-plugging operation, HPOC is to contact the COGCC. Please provide your consent to the re-plugging operation by signing in the space below and returning it in the provided envelope.
