Perform reclamation in accordance to COGCC 1000 series reclamation requirements including, but not limited to, compaction alleviation, recontouring/ re-grading, removing cattle guard, and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels on the location and access road. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.

<p><b>RECLAMATION COMMENTS</b></p> <p>Inspection doc. #682502594, #682502917 and #682503690 required operator to perform reclamation, including but not limited to, removing cattle guard, compaction alleviation, recontouring/ re-grading, and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels on the location and access road.</p> <p>Unable to find evidence that additional reclamation has been conducted per the corrective action; Access road has not been recontoured/regraded, cattle guard remains at entrance, road remains bare and exposed soil, or predominantly undesirable weedy plant species. Location remains bare and exposed soil or predominantly undesirable weedy plant species. Unable to find evidence that additional reclamation has been conducted per the corrective actions and per 1004 reclamation requirements.
