Comments

- Requesting 502.b. variance to rule 603.a.(1) for wellhead being less than 200' from a public road. Previous conductors were set, plugged and abandoned on the pad. Letter attached along with waivers.
- Ursa is the surface owner and well will be drilled from an existing pad.
- Ursa beneficially reuses surface and production cuttings that pass COGCC Table 910-1 standards. Ursa collects representative samples to evaluate cuttings. Cuttings that pass standards are beneficially reused either offsite or onsite during the interim reclamation phase. Proper approvals are received prior to reuse such as landowner authorization and COGCC Form 4 sundry notice. Cuttings that do not meet Table 910-1 standards are either treated onsite or disposed of offsite at an approved solid waste facility.
