The flowline on-location at the Orchard Federal Disposal 1 pad location was repaired, with the original flowline removed and sent for analysis. This repair was followed up with a pressure test, which passed. A replacement Flexsteel line has been ordered and will be installed in lieu of the repaired flowline to minimize the potential for corrosion. While Caerus waits on the Flexsteel, the well will be used sparingly.
