On Thursday 6/27/2019 at approximately 12:15, I, Inspector Emily Waldron, and Inspector Lou Colby conducted a joint field/stormwater/reclamation inspection at Sandridge Exploration & Production LLC Hebron 01-18HR 414127 in Jackson County Colorado. While there, we observed production.  
During this inspection the following possible compliance issues were observed:  
Unlabeled tank. See photo 1. Install sign to comply with Rule 210.d by 9/3/2019.  
Non-reportable spills - stained soil in former tank battery, separator areas, pump jack, and multiple other areas of location. See photos 2-9. Comply with Rule 603.f, securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition per Rule 605.d, control and contain spills/releases and clean up per Rule 906.a, and properly treat or dispose of oily waste in accordance with 907.e.  
Gravel/soil piles with trash, debris, stained soil stored on location. See photos 3-4. Comply with Rule 603.f by 9/3/2019.  
Equipment stored on location. See photo 10. Comply with Rule 603.f by 8/2/2019.  
2 - 2" steel risers not marked for LOTO or marked for abandonment at 40.58389, -106.41602. See photo 8. Comply with Rule 603.f by 7/8/2019.  
No evidence of berm or liner on unlabeled tank. See photo 1. Repair or install berms or other secondary containment devices per Rule 605.a.(4) by 8/2/2019.  
Site degradation occurring. All location stormwater BMPs need maintenance. Install or repair required BMPs per Rule 1002.f by 8/2/2019.  
A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
