 (1) Within 30-days of installation or discovery of a domestic tap connected to the operator's flowline, an operator must submit a Flowline Report, Form 44, to the Director to register the tap. Operators must register known domestic taps that were installed prior to May 1, 2018, by submitting a Flowline Report, Form 44, to the Director on or before October 31, 2019. The registration must include the latitude and longitude of the flowline or wellhead connection for the domestic tap and the street address or the latitude and longitude of the point of delivery.
