While there, I observed producing facility. During this inspection the following possible compliance issues were observed: 1. Appears to be some type of battery left inside fencing that contains wellhead. COMPLY WITH RULE 603.F. (Corrective Action Date: September 16, 2019) See attached photo #3 in individual wellhead photos (ALM 33U-234). A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
