The former HSR-Blank 15-5A well (API: 05-123-16635) was P&A'd on January 31, 2017 according to Form 6 Document Number 401218173. On June 11, 2019, LTE conducted a final reclamation inspection for the former HSR-Blank 15-5A well pad (Location ID: 328929). The former well pad has successfully been returned to agricultural use. The associated tank battery remains active and is located 0.36 miles east. LTE personnel located the P&A wellhead location using a handheld Trimble (R1) Global Positioning System (GPS) unit and latitude and longitude coordinates obtained from the COGCC online database. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location. Please see the attached letter, general site location map and photographic log.
