The former HSR-Buerger 10-5 well (API: 05-123-16632) was P&A'd on August 23, 2016 according to Form 6 Document Number 401112103. On June 11, 2019, LTE conducted a final reclamation inspection for the former HSR-Buerger 10-5 well pad (Location ID: 328927). The former well pad has successfully been returned to agricultural use. The inspection determined that final reclamation has been achieved in compliance with COGCC Rule 1004, which applies to reclamation of agricultural lands. The associated tank battery remains active and is located 0.42 miles south east. LTE personnel located the P&A wellhead location using a handheld Trimble (R1) Global Positioning System (GPS) unit and latitude and longitude coordinates obtained from the COGCC online database. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location.
