Comments:

The former HUNZIKER 26C-4HZ well (API: 05-123-40888) was P&A'd on April 26, 2019 as identified in the Form 6, Document Number 402038863. On October 14, 2019 LTE conducted a final reclamation inspection for the HUNZIKER 26C-4HZ well pad and has determined that the site is in compliance with final reclamation requirements per COGCC Rule 1004. The former HUNZIKER 26C-4HZ well is located on an active pad (Location ID: 440427) and the associated active tank battery is located 0.06 miles south of the well pad. The former HUNZIKER 26C-4HZ well pad remains in use servicing Kerr-McGee producing wells: API: 05-123-40891; API: 05-123-40893; API: 05-123-40844; API: 05-123-40892; API: 05-123-40890; API: 05-123-40887; API: 05-123-40846; API: 05-123-40886; API: 05-123-40847; API: 05-123-40889 and API: 05-123-40845. All disturbed areas have been compacted and stabilized with road base to minimize erosion. LTE personnel located the P&A wellhead location using a handheld Trimble (R1) Global Positioning System (GPS) unit and latitude and longitude coordinates obtained from the COGCC online database. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location. Please see the attached letter, general site location map and photographic log.
