Comment: There is vehicle rutting occurring along the access road. There are culverts filled in with sediment. There is a deep erosion channel along the side of the access road that needs to be repaired. Areas of erosion will need to be repaired and stabilized. BMP's must be implemented in accordance with good engineering practice and must be maintained. It appears oily waste on engine skids have been cleaned up. There is an area of oil stained soil which will also need to be cleaned up.
