This location does not comply with Rule 1004. Reclamation rules require all equipment to be removed within three months of plugging. One riser remains at the Kugel 42-18 well location. Refer to the attached inspection photos.

Operator has removed all equipment from the associated offsite tank battery and has performed final reclamation activities with the evidence of drill rows and straw crimped mulch.

Operator shall perform final reclamation activities for the well location and access road no later than 7/30/2020.

Corrective Action:

Comply with Rule 1004.a. to remove (regardless of ownership) all debris, abandoned gathering line risers, and flowline risers, and equipment within three months of plugging (07/30/2019) the associated facility. All work should have been conducted by 10/30/2019.

Corrective action date is being backdated to when all equipment should have been removed.
