Comment: Of biggest concern, is washout on access road, .2 miles down road to the East as one approaches location after turning off main Lease Road. One area of cut slope at Location is eroding, and one area adjacent to rockered drainage on fill slope is eroding. Refer to Photo Log attached for detail of site conditions.

Corrective Action: Install or repair sufficient/effective BMPs in accordance with, and monitoring per Good Engineering Practices per Rule 1002.f
CA Date for repair of Access Road is ASAP, as there is immediate threat to Surface Water Quality as intense, Spring precipitation events are occurring. Location BMP repairs should be completed by 4/30/2020.
