While there, I observed a shut in facility. During this inspection the following possible compliance issues were observed: 1. Equipment not anchored (separator, H2O tank) According to COGCC maps, location is within flood plains. Anchor equipment ensuring anchors are engineered so the equipment will resist flotation, collapse, lateral movement, or subsidence per Rule 603.h.(2)B. Refer to the 603.h guidance document for further details. (Corrective Action Date: July 28, 2020) See attached photos #5, 6. 2. Inadequate berm surrounding tank battery.
