During this inspection the following possible compliance issues were observed:

1. Appears to be stained soil at wellhead under master valve. Conduct maintenance on equipment, cleanup stained material and review self inspection processes per Rule 1002.f. (2).d. (Corrective Action Date: April 20, 2020) See attached photo #3.
