Comment: This location does not comply with Rule 1004. The well location and well location access road have unmanaged List B Colorado noxious weeds, Scotch and Musk thistle, with no establishment of desirable plant species. No new thistle shoots were observed, only rosettes.

The associated offsite tank battery has not been reclaimed. There does not appear to be a surface owner variance request on file for any of the associated well locations.

Corrective Action:	CA #1: Comply with Rule 1004 to control and manage all noxious weeds by 5/27/20. CA #2: Comply with Rule 1004 to perform final reclamation activities for the well location and well location access road no later than 11/15/20 or as soon as environmental conditions permit. CA #3: Comply with Rule 1004 to perform final reclamation activities for the associated offsite tank battery no later than 11/15/20 or submit a final reclamation variance request.	Date	05/27/2020
