The following compliance issues were resolved:

- 1) Weed debris.
- 2) "911" was added to signage.

The following compliance issues are uncompleted:

- 1) Missing operator phone number on meter building. Photo 5. Complete by 9-30-2019.
- 2) Well head sign missing. Photo 3. Complete by 7-15-2020.

Note: A flow line riser gas leak was observed. No fluids were visible. Photo 4. The inspector contacted the operator at 10:51. The operator shut off the gas at approximately 11:15. Before the inspector left the area a crew had started to replace the location flow line.
