<p><b>COGCC Inspection Report Summary</b>  On Wednesday 5/20/2020 at approximately 11:00 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the KPK Stroh #1 location #319205 in Weld County, Colorado.</p> <p>While there, I observed that the battery sign is incorrect, a missing NFPA placard on the east crude oil tank, the DCP Midstream meter calibration card was out of date and miscellaneous trash around location. During this inspection the following possible compliance issues were observed: Rule 210.b. with a corrective action date of 8/21/2020, Rule 210.d. with a corrective action date of 8/21/2020, Rule 329 with a corrective action date of 8/21/2020, Rule 603.f. with a corrective action date of 8/21/2020.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.</p> <p>This is a summary of the inspection report.</p>	petersont	05/20/2020
