<p><b>RECLAMATION COMMENTS</b></p> <p>FIR #680600788 dated 6/9/2016 observed that the Location does not meet 1004 reclamation requirements; Equipment remains, Location and access road requiring compaction alleviation and contouring. FIR required Operator to perform the following corrective actions by 10/25/2016: Equipment needs to be removed and well pad and access road need to be de-compacted, re-contoured, and seeded to comply with 1004 series rules by October 15, 2016.</p> <p>It was observed in this inspection that the Location remains out of compliance with 1004 Rules and corrective actions; Anchor equipment remains on NW corner of Location; Gravel remains on Location and access road; Location and access road has not been contoured and compaction alleviation not conducted and site/road revegetated; noxious weeds evident.</p> <p>Corrective actions from FIR #680600788 have not been addressed, therefore corrective action date remains applicable.</p>	trujilloam	05/29/2020
