## Comment

Well 051-06101 Form 2 permit 401266926 expired 7/13/2019. Operator in process of re-permitting well (Form 2 #402033650, "In Process"). Operator submitted and received a delayed IR waiver (Doc. #401293533) for 2 years, expiring 2/5/2020. Operator resubmitted a second delayed IR waiver (Doc. #402247341), requesting the full 5 years to delay interim operations; Request pending approval.

It was observed in this inspection that Location is out of compliance with Rule 1003.f "Weed Control"; Canada thistle rosettes observed within ditch on the north end of the pad. This is a Colorado state listed noxious weed that requires management. Noxious weed concerns observed in multiple inspections dating back to 2016.

Corrective Action **Comply with Rule 1003.f and conduct weed management.**
