General Comment:

On 7/6/2020 Catherine Roy conducted a reclamation and stormwater inspection, and followup to inspection 693901479 conducted in March 2020. During this inspection the following compliance issues were observed:

- Weeds (Russian knapweed) need to be controlled. Corrective action date is back-dated to 6/1/2020. Additional treatments will be needed.
- April 2020 FIR Resolution Form documents operator's response to corrective actions identified during the March reclamation inspection. Review of operator submitted photos, indicates that the weeds treated were perimeter weeds and weeds around project facilities. Russian knapweeds, a state and county-listed noxious weed, were not herbicide treated at that time.

1003 f. Weeds Noxious weeds? _____

Comment Approximately 2000 Russian knapweeds observed within the interim reclamation areas. No evidence of herbicide treatment observed on knapweeds. March 2020 FIR Resolution Form does not document that noxious weeds are being controlled.

Corrective Action Control weeds at the appropriate time, and no later than 11/1/2020. Per CSU extension, control of Russian knapweeds requires a multi-pronged treatment approach as a single control strategy will not likely be sufficient. Areas treated for Russian knapweed should be reseeded with desirable perennial grasses in the fall to compete with the treated knapweed. Multiple corrective actions have been issued for Russian knapweed infestation at this location. Infestation appears to be spreading. Corrective action is back-dated to previous corrective action date to document duration of non-compliance.
