Michelle,

Thank you for using the COGCC Online Tool to file your complaint. Your information has been entered into document number 200449100.

To investigate your concerns, I have reviewed records in the vicinity of your residence. Within a half mile radius there are no producing wells, no drilling activities, no lateral well bores, and no seismic activity. I expanded the search to 2 miles and was only able to identify 5 producing wells. These wells were mostly drilled in the 1970s or 1980s.

COGCC can only use our limited resources to investigate concerns relating to activities within our jurisdiction, and based on the above described review it does not appear your concerns will meet this criteria.

COGCC staff did not identify any violations of COGCC rules that would lead to the issuance of a notice of alleged violation (NOAV) related to your complaint. Accordingly, the COGCC has closed your complaint.

You may wish to reach out to your local government, your local health department, or the Colorado Department of Public Health and Environment to inquire about ongoing construction-type activities and/ or seek assistance with your health concerns.

My name is Michelle Jones and I live at 6760 E 129th Ave, Thornton CO 80602. I own the house and land, with Warranty Deed stating "For Fee Simple," paying significant amount for land value on annual property taxes, and no exceptions or other contact or ownership info included in any of my closing documents saying otherwise.

I have a sinkhole in my backyard and don't know from what. Someone keeps coming onto my property in the middle of the night and filling it with noxious weeds and sand without telling me. Once I had a gap of about 3" in height with no ground dirt to support it, also filled in repeatedly with same weed sand and not telling me. I hear lots of noise at all times of the day and night, and see projector boxes on top of several roofs in my neighborhood, that project disjointed images over large areas of a static house that doesn't fit in or belong there, where I can see and hear heavy duty mining and tractor like equipment and dumpster containers and large diameter width black accordion tubing along some of my neighboring houses.

I am inundated with strong chemical smells which give me bad migraines and cause stabbing stomach and abdominal pain, heavy pain and stiffness in all of my body joints, severe coordination and balance problems, and nerve twitching and tremors, with nerve pain and neck weakness, dizziness, intense drowsiness that I can't control, abdominal stabbing pains, quick onset internal thermal heating with severe pouring down sweat all around my hairline to rapid dripping status, followed by freezing deep cold chills that chill to the bone, bone brittleness and pain, shaking with muscle cramping and weakness with odd sucked in indentations and pain, at times heavy static electricity feeling like it's trapped in my body, and feel magnetic pull in my head and eyes and lumbar back and hips from outside my bathroom window. It took me a while to comprehend what it was, with only some but not all things described happening at a time, confusing it with symptoms of injuries I am recovering from after three surgeries so far.

I called Xcel to come out and check for a gas leak in the area of the back right corner area of my backyard and around my house and they said they found nothing. I also saw thick pinkish tinted clouds of dust so thick it made me cough and caused scratching in the back of my throat when drawing in breaths, and the clouds were so thick at times I couldn't see the house next door to the West of me. I had also started seeing eerie face images in it and in clouds and reflected in fog coating my bathroom and bedroom mirrors.

I started feeling strong electric shocking throughout the entire floor of my home and through my furniture, which I called Thornton Police about, and told them I suspected illegal underground mining and/or gas & oil theft underneath my home causing physical health problems in feeling electro shocked constantly around the clock with no relief, along with what felt like intermittent but often sonic vibrations underground. I also told them I thought it might be coming from a seismic monitoring device placed in my front yard by Great Western Operations Company, and after finding out it wasn't for earthquake studies or to measure underground movement, but was for exploration purposes, suspected they had found something and were mining or something. I read online that dust from mining with radiation can cause lung and stomach cancer, and was in fear for my health. The police said they didn't feel anything from outside on the front porch, and said if they were underground, how would they be able to find them? They then suggested I call Xcel and Comcast, my cable provider, and Great Western to see if any work was being done in the area.

I called Xcel who said they weren't doing it and didn't see anything unusual on their monitors. I called Comcast and they said it wasn't them. I called CenturyLink to have them come over to professionally completely disconnect their Qwest box wired into my outside circuit breaker box and check to see if that was causing it, which they did and said it wasn't them. I saw odd wiring changes in what looked like my outside sprinkler system compartment in the ground and called City of Thornton Water Quality to ask if it was theirs, which they said it was not and that it was

mine if it was on my property. I also reported concerns about an unexplained thick white oily like substance that clogged up my ice/water dispenser in my refrigerator and left a residue on my dishes after dishwashing, and told him it wasn't hard water that I had experienced before in a previous home, and told them about my worries it might be radiation, after finding what looked to me like Uranium rocks in my backyard. He assured me that the water was fine and that due to the direction of the water flow it was very unlikely any form of radiation could get into the water pipes to contaminate the supply, and if any problems occurred, they had a separate portable water source up north by the Platte River to switch to. We discussed testing it to make sure, and he told me it takes a long time to get the results back and is costly and I may end up having to pay for it, but they would if I wanted. I told him I'd prefer to get expert confirmation on the rocks I found first before going through all that, which I am still unable to get an expert to call me back to find out, and have tried all I could find, only finding University of Colorado Geology, which was contacted on my behalf on what I think might be a large dimethyl mercury and cinnabar rock that I carried across my yard and had scary symptoms of disorientation on where the ground and gravity was, and that I was telling my legs to walk but they wouldn't until trying repeatedly and with effort was able to take one step then the rest followed on autopilot, and had made me feel dizzy to nearly passing out and so weak that by the time I got to the other side of my yard, was unable to bend over to put the rock down, feeling I'd fall and pass out, so I dropped it to the ground from where I stood and went inside to eat and lay down. I had bad headache and nausea and was bed ridden sick for about three days. After it wore off, I went back outside to look closer at the rock and just touching it carefully with thumb and index finger to turn it to photograph it, found that it had turned the inside palm of my hand black under the skin and was worried about poisoning or toxic effects, so I called the TOXCALL hotline for the Health Dept, who asked me to send photos, which they forwarded onto University of Colorado Geology, who replied back that they didn't think it was dimethyl mercury and cinnebar and advised since I had bad effects from it, not to touch it again. I contacted School of Mines and COGIS and left messages and no one has called me back. My stepfather sent a photo of what looks like a UV light crystal laying on the outer edge of the sinkhole to USGIS who said to take it in someplace locally. I contacted Stephanie Sykouras who is a professional geologist two or three times and never got a reply. I called the Adams County Field Range Supervisor, and his secretary said she'd check into it with City of Thornton and COGCC while he came out to check it out. She called me back and said neither of them were conducting any activities and that per COGCC, there were no approved permits to do anything at all within at least a one mile or five mile radius of my home address.

I called Great Western Oil & Gas Company by accident, confusing them with Great Western Operations Company who did the seismic data study, and they said it wasn't them. I then found the form on the monitoring request and called Great Western Operations Company to ask them. The receptionist asked for my address, typed it in, and told me, "Oh...ummm...yeah I'm gonna have to have someone call you back on this," and took my name and number. The same woman named Natalie that had called me back from the other company, called me back from this one. I was confused wondering if I had called the first one by mistake to ask about it this time, and she said no, she was calling me back for each one, and that they were "like two different companies, but kinda like one company, if that makes sense," which I told her it really didn't but I wasn't calling about that anyway, and she said they weren't conducting any operations anywhere near my address, and the closest activity was 40 blocks north on 168th and Holly St. I asked her if I could get a copy of the data from their machine to see if it showed anything odd or helpful or unusual going on under my house, and she said she didn't think there was any. She says she'd check and if there was she'd call me back and send me a copy.

I then felt a large vehicle hit hard up against the bottom of my house foundation, which was alarming. I also noticed lots more problems with ground and foundation settling and instability and sinkholing, as well as my fence line sinking several inches below my other four corners neighbors in the back East corner of my backyard, as well as my stone layered patio waving with humps riding and falling along its once level surface, saw red and crayon bright green and black

liquids seeping up in different areas spanning my whole backyard, and black liquid absorbing up onto the bushes and trees and plants stems and seeping up into the fence boards of not only my home but also three houses across and three houses behind square area as well as gray discoloration patches in their yards as well. I called Sinclair knowing their pipeline is about half a block away from me, and told them I was worried about their pipeline stability due to what was going on with rapid settling of my home in my foundation, porches, cracking across my driveway, way excessive tar street patching, white material running down the sidewalk gutters, the sidewalk separating from the asphalt and having a crack running down the full length of the curb base all the way up and down my street, rust and corrosion affecting all of my cars and manhole covers for water in my front yard, a 3" separation running down my stairs inside my house separating the runner from the floorboard down the entire flight of stairs, fence decor that was falling off the fences repeatedly in my backyard, exterior stone brick patching and spackling unevenly and layered in spots and using dark black mortar in between the stones, large patches of grass turning red and browning and yellowing, and a whole row of bushes and ivy in my backyard zen garden area looking black swampy under them and then all being rapidly killed and turning crispy brown and black with large divets in various areas, and I had found several more rocks on my property, including what I think may be a Uranium geode and a volleyball size Plutonium rock with tiny clock or mechanical gears compressed all over the surface, and what I suspect to be all five other types of Uranium and two Uranium ores, four different means of formations of what I think is bright yellow buttery gold, in standalone nugget form, embedded in a thick vein in black granite looking rock, sedimentary horizontal flaky layers rocks, cluster or rocks hit again and turning clusters into clear chunky mixed with same size gold chunks throughout, plus normal gold ore cluster rock and bread rock gold ore, large size possible diamonds, other metals in nugget form, including two silver color ones and one bronze colored one, more dimethyl mercury, pink gold which I've never heard of in flake form inside pink hard rock, and what I think may be ocean floor rock and even possibly Earth core rock, being quite intensely almost stop sign red in color but containing not hardly any radiation faces and almost crystallized with white fatty looking steak like marble run through it coated in light brown compressed mud and I think the red rock material may be cooked solidified energy from Earth's core cooling as it came to the surface, plus about ten other different rocks that I think may be new elements, due to them containing electricity and appearing to be inverse magnetic soft formed rocks, which I have never heard of, and hurting my fingers to hold them for about 30 seconds, like heat or acid burning feeling and shock electricity feeling, after carrying the big Plutonium rock for longer duration and it causing no pain or discomfort at all. Also beautiful amethyst purple and faded magenta pink marbled with white clay like rock material nearly crystallized to glass, which I've never seen either, and flagstone deep burgundy red color but looking like compressed liquid and dense and uniform throughout which is a rock material I've never seen or heard of either.

Anyway back to the complaint, and sorry to get carried away with my excitement there! I love rocks and these are truly spectacular! :) lol OK so, I had also started having lots of 360 degree problems in every area of my life that I have struggled hard to keep up with and barely managing to keep afloat, and I can't find anyone to look at these rocks or police to help me due to odd completely ridiculous flacid responses to things like attempts on my life, repeated breaking and entering when I'm home alone or just with my daughter, oppressive can't breathe hacking of things I never guessed could be hacked and through orifices I didn't even know I had, and even people coming to my home and staying with me pretending to be my friends and family members and finding out after the fact they were strangers to me, I suspect to perform interior patch work to hide rapid settling damage, surgeries and medical procedures gone wrong causing me more injuries consistently for four surgeries and a lumbar back injection, puncturing and herniating additional discs and giving me a spinal leak and infection, and I have reasonable basis and supporting research from unbiased sources to cross verify, and evidence and viable bases for my beliefs as to what is happening here any why that a prosecutor would love...if I can only linebacker slam my way through all this to get to one that isn't bought for a dollar or too busy to investigate, especially now with all this virus stuff going on, and I am hoping there is something

you can do to help me find out who is doing this and stop them and help me get an expert opinion on these amazingly spectacular rock finds just on my property alone that had potential to illuminate history and provide new forms of elements and new forces of physics that could potentially in my hopeful and excited view...if purchased by companies to maintain US ownership...balance out the World's oil supply and wealth with the Middle East, in fact suspecting this is the opposite side of the Earth's consequential impact coming up from what occurred there giving them their resources and oil supply. Please don't think me too crazy, I know it's a lot, but its my honest truthful best attempt to figure out and make sense of all that is going on around here, and when combined with my excitement that gets me through the hardest times I've ever encountered in my life including the death of my husband five years ago, and amplifies my natural optimism and faith that things will one day work out and the cavalry will hear me and understand what's at risk here being worried these rocks are daily absorbing into the oil liquid in the same area, and holding out for a miracle in someone that will hear me and want to help me...all sum total making me delightfully batshit crazy as worst case scenario...delightfully not harmfully...and could make for a landmark way to spend an afternoon at the very least at risk, and a better investment than President Trump is hoping to make in purchasing Greenland and saving and balancing humanity and saving a Princess at best, which makes for a good day at the office. ;) Seriously though, coping humor and flights of fancy aside...Please help me. And just come over if you'd like, since I'm always home due to disabled broken down vehicles, and have a hard time getting through both ways by hacked phones. Thanks in advance and here's to hope...cheers and hoping to be seeing you soon! :)
