Noxious weeds (Bull thistle, Musk thistle, Houndstongue) observed on the production and interim areas of the Location, and access road. Though plant senescence is evident on some plants suggesting herbicide treatments may have been conducted, any management appears to be insufficient as the majority of weeds observed in the inteirm areas appear viable.
