Unused meter run. See photo #1166 and #1827 with a previous corrective action date of 8/13/20. Multiple unmarked deadman. See photo #1168, #1169 and #1830 with a previous corrective action date of 5/27/20. MIT required on well. With a previous corrective action date of 8/13/20.
