Comment:

The entire length of the access road to the location has been graveled. There are areas along the road where erosion is beginning to occur. Ongoing erosion control will need to be performed. The road will need to be stabilized for long term stabilization. The area of the road where the soil slough occurred was repaired and a culvert was installed. It was observed that additional sloughing may have occurred due to exposed liner. This area will need to be monitored for long term stabilization.
