-Revegetation and remediation needs to be conducted within the northeastern project area.

-Soil sampling and remediation will likely be needed to revegetate this area. Operator needs to coordinate with surface owner to determine whether this portion of the project area should be revegetated to cropland or non-cropland, as it is on the edge of an irrigated hay field. Revegetation needs to be conducted using seed mix requested by surface owner or local NRCS/soil conservation service when the desired land use is determined here.

-Revegetation needs to be completed by 9/15/2020 or as requested by surface owner for crop field.

-Monitoring needs to be continued until seeding areas meet 1004 reclamation standards.

HighPoint Resources' reclamation consultant performed periodic monitoring of this location in June, 2020, and a report of their findings is included with this response. The consultant collected soil samples from both the project area and an adjacent undisturbed area, and the results are provided in the included report. Results from soil samples taken previously at this location are also included. Based on their observations and the results for the soil samples, the consultant is recommending treating the area in the near future with gypsum and then allow time for the excess chlorides to leech from the soil. Based on subsequent soil sampling to be conducted in the fall 2020, either additional treatments for chloride will be implemented or application of fertilizer and reseeding the area will occur in spring 2021. Weeds on the location were sprayed by Premier Weed Management on June 13, 2020 (see attached invoice with detail of application). All treatments and other future work will be coordinated with and approved by the landowner and/or tenant farmer. Regular monitoring of reclamation success will continue until such time the reclaimed area meets the 1004 reclamation standards.
