Cottonwood Consulting representatives were on site collecting soil samples during this inspection. Fluids day lighted in a field along the access road to the Hanstedt 7U-1 #4. The release flowed into a road side ditch and ultimately into a pond. The pond was reportedly dry prior to the release occurring. Water samples had allegedly been collected on 10/28/20.
