**General Comment:**

On 12/08/2020, Reclamation Specialist Trujillo conducted an interim reclamation and stormwater inspection at Laramie Energy's Cascade Creek 697-09-61 location in Garfield County, Colorado.

This inspection is a follow up to FIR #696201787 and #696201980 to document compliance with the following corrective actions:  
1002.f.(2): Stormwater

This inspection is also a follow up to Resolution doc. #402527730 stating corrective actions have been completed.

It was observed in this inspection that the Location remains out of compliance with Rule 1002.f and corrective actions.

**Comment:** Previous inspections observed that BMPs were missing, or insufficient to stabilize the cut slopes on the north and western areas of the location, and required Operator to comply with 1002.f rules. Operator submitted FIRR No. 402527730 stating CAs have been addressed.

It was observed in this inspection that Operator implemented mulch on the cutslope of the northwest corner of the Location behind the tank battery; BMP has not been installed in accordance with good engineering practices or maintained in proper functioning condition. BMPs not installed to stabilize/protect the remaining cut slopes on the north ends of the Location as identified in the previous inspections.

BMPs remain insufficient to stabilize and protect the cut slopes.

**Corrective Action:** Corrective action has not been addressed in its entirety and remains applicable: Install or repair required BMPs per Rule 1002.f.(2)C.
