Comment:

Records show well PA 1985. Since plugging, Chevron constructed a new location and drilled the M B Larson C 1 AX (103-10763) within the same area as the Larcon M B C-1.

It was observed in this inspection that various concrete and pipe debris (possible remnants of the well marker) associated with the PA'd well was removed and placed on the southern areas of the "C 1 AX" during pad construction. See attached photos.

Corrective Action: **Comply with Rule 1004.a and remove concrete and pipe debris remaining on the Location.**
