Comment

Limited visibility due to snow cover at time of inspection prevented Reclamation Specialist from conducting an accurate assessment of the reclamation; Interim reclamation of the Location appears to have been recently conducted; Location has been reduced to areas reasonably needed for production; contouring performed. It was also observed that interim areas appeared to have been ripped once, in one direction rather than cross-ripped pursuant to Rule 1003.c. Due to frozen conditions, Reclamation Specialist was unable to dig a test pit; a followup inspection will be conducted in the future growing season to determine compliance with 1003 Rules and requirements.
