The Eberle 13-32 CHZ facility was initially owned and operated by Synergy Resources. PDC Energy acquired the facility in January 2020. PDC is following up to install three (3) monitoring wells at the facility that Synergy Resources voluntarily agreed to install. PDC's proposed follow up activities were discussed and submitted to COGCC staff on October 1, 2020.

Three monitoring wells will be installed within and down-gradient to the current facility extent. Proposed well locations are illustrated on Figure 1. Following installation, monitoring wells will be surveyed and sampled to assess water quality conditions and determine a groundwater flow direction. Groundwater samples will be submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX) using EPA Method 8260B.

Per the agreement outlined in the Form 2 submitted under Document # 400534181, three monitoring wells (BH01 - BH03) were installed to October 19, 2020, to monitor the alluvial groundwater system. Groundwater analytical results collected during the initial groundwater assessment indicated that BTEX concentrations were below the applicable COGCC Table 910-1 groundwater standards in all three monitoring wells. Based on the results, groundwater monitoring will continue on a quarterly schedule.

GROUNDWATER MONITORING

On October 19, 2020, three monitoring wells (BH01 - BH03) were installed to confirm the absence of dissolved-phase hydrocarbon impacts and monitor the alluvial groundwater system. Groundwater monitoring will continue on a quarterly basis at the three site monitoring wells. Groundwater samples will be submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260B in accordance with Table 915-1. In addition, site-specific inorganic parameters, including total dissolved solids (TDS), chloride, and sulfate, will be evaluated at the source, up-and down-gradient monitoring wells during the second quarter 2021. Contingent on analytical results, inorganic parameter analysis will be discontinued after one sampling event.
