Comment:

There is gravel that remains at the beginning of the access road and a pile of gravel near the location. The cattleguard remains and the fence has not been installed back to the original position. It appears the location has been cross ripped however a crop has not been re-established. The surrounding crop vegetation will need to be planted and established. All reclamation should have been completed within 3 months of abandonment. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately to obtain compliance.
