On Monday 4/19/21 at approximately 12:00 hours, I, Inspector Corey De Paolo, Conducted, a follow up inspection at CAERUS PICEANCE LLC FEDERAL-68S95W /7NWNW, Location #311684 in Garfield County Colorado.

Refer to document #699802832 inspection conducted on 3/26/21. Not all previous corrective action have been completed.

While there, I observed normal production operations.

During this inspection the following possible compliance issues were observed:

1) Location lacks stabilization. See photo #3534, #3314, #3535 and #3315. No form of tracking control at entrance to location. See photo #3538 and #3316. Sediment has been transported off of NE end of location. See Photo #3536. Sediment is choking off vegetation. See photo #3536 with a previous corrective action date of 4/9/21.

- Location is located in a high priority habitat area.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
