General Comment:**COGCC Inspection Report Summary**

On Monday 4/19/2021 at approximately 1000, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP Mead 30-13, at Location # 335196 in Garfield county Colorado.

While there, I observed normal production operations. Inventory on location is the same as previous inspection. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat and Wildlife Management Area. Also location is within or in close proximity to the 411 water protection area. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for tracking pad. C/A from previous inspection document #700702442 for location lack of stabilization/compaction is still within C/A date (5/19/2021).

This inspection was focused on the tracking C/A from previous inspection # 700702442. C/A has not been completed, therefore C/A date remains the same.

During this inspection the following possible compliance issues were observed:

1. Access still show signs of lack of stabilization/compaction. Tracking is evident onto county road 317 (beaver creek road) Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
