It was observed in this inspection that the Location remains out of compliance with COGCC rules and the corrective action: Location not reclaimed in accordance with Rule 1004.a; Location has not been recontoured/regraded/reclaimed.

Corrective action from Inspection #680100590, #696202182 and #696202511 has not been addressed and remains applicable.

Corrective Action:

Comply with Rule 1004.a and conduct final reclamation including, but not limited to, recontouring/regrading, compaction alleviation and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
