Comment:	Operator did not properly remove and dispose weed debris in response to a corrective action Field Inspection Report (Doc. # 699302797) back in November 2020. Operator dumped weed debris onto the adjacent field east of the battery location. Refer to Photo 4. Complainant removed most of the weed debris that was dumped off location but left some behind to demonstrate non-compliance.		
Corrective Action:	KPK shall remove weed debris dumped off location and shall provide documentation they instructed contractors about proper removal and disposal of weed debris. The corrective date is the date the location was observed out of compliance, as it should be in compliance at all times.	Date:	04/22/2021

Comment:	At the time of this inspection, cheatgrass growth was observed along the main lease road, well location access road, well location and battery. Field bindweed, Kochia rosettes and puncturevine were also observed throughout the above locations. Also, Canada thistle, a List B Colorado noxious weed, rosettes were observed at the outlet of the culvert along the well location access road.		
Corrective Action:	Comply immediately with Rule 1003.e.(1) to control and prevent invasion of undesirable species and noxious weeds on cropland. The corrective date is the date the location was observed out of compliance, as it should be in compliance at all times.	Date:	04/22/2021
