There are noxious weeds that are growing along the access road and at the location. The weeds could not be observed during the dormant season but have emerged and need to be controlled. Additionally there is an area at the location which consists of undesirable weeds. Additional monitoring and management needs to be performed to complete reclamation of this location. Overall the location is progressing.
