While there, I observed a shut in wellhead. During this inspection the following possible compliance issues were observed: 1. Weeds inside tank battery berm, near heater treater and at pumpjack. Remove weeds to comply with Rule 606. (Corrective Action Date: May 27, 2021) See attached photos #3-11. 2. Unused risers north of heater treater. If risers are needed for future use the operator must LO/TO within 24 hrs. If risers are no longer needed on location, operator must remove per Rule 606. (Corrective Action Date: August 13, 2021) See attached photo #11.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
