Comment:

The location is not in compliance with the reclamation requirements. There is an abandoned compressor engine and a steel tank. There are abandoned pipe risers that have not been removed. The area around the tank and equipment is bare of vegetation which indicates soil issues. All equipment needs to be removed and the location reclaimed. Previous inspection corrective action has not been completed. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately to obtain compliance
