Comment:

Previous inspection observed concrete pad/debris remaining on the Location. Inspections required Operator to comply with 1004 Rules by 11/1/2019.

It was observed in this inspection that additional reclamation has been performed. Reclamation Specialist conducted a germination transect and observed that desirable plant germination was not occurring over the reclamation area (~0.05 seedlings per 1/2 sq. meter); additional seeding likely required; a followup inspection will be conducted in a future growing season to determine compliance with 1004 rules. This corrective action has been addressed.

Noxious weeds (Halogeton) observed establishing on the reclamation area.
