Comment

Inspection #696201347 on 6/3/2020 observed that interim reclamation and revegetation activities were conducted; Location within the 2nd growing season since additional reclamation work was performed.

Reclamation Specialist conducted germination transects and observed that sufficient desirable plant germination/establishment was not occurring over the reclamation area (~0.125 seedlings per 1/2 sq. meter). Approximately 1 seedling was observed for every 8 quadrats. Additional seeding will likely be required to ensure reclamation progresses towards 1003 standards; a followup inspection will be conducted in a future growing season to determine compliance with 1003 rules.
