Comment:

Previous inspections observed equipment and debris remaining on the Location, and that the Location was not progressing towards revegetation standards. Inspections required Operator to comply with Rule 1004.a.

It was observed in this inspection that the Location remains predominantly bare soil; no documentation has been submitted showing additional work was performed; Reclamation Specialist was unable to observe evidence that additional, or adequate, reclamation activities were conducted on the Location and former access road in accordance with 1004 rules and corrective actions. In addition, noxious weed establishment (Halogeton) was observed along the access road and Location; weed management also required.

Corrective Action:

Original CA remains applicable: Comply with 1004.a; conduct additional reclamation activities to facilitate desirable vegetative establishment.

Comply with 1004.e; conduct weed management
