Environmental**Spill/Remediation:**

Comment: No Operator personnel or equipment onsite at time of inspection. Inspection is open with approximate dimensions of 50'W x 60'L x 20'D. No water is present in the excavation. Ends of flowline are exposed in the north and south walls of excavation. Cattle panel fence is down on south side of excavation. Bermed area of oily waste from last inspection has been removed. Apparent clean overburden of 50 cubic yards is staged east of excavation. What appears to be a 1" diameter piezometer has been installed adjacent the east side of the excavation.

Corrective Action: Operator to submit Form 27 with Site Investigation and Remediation Workplan for remediation of Spill (this was due by April 19, 2021). Form 27 shall include any confirmation soil sample results collected to date, proposed schedule for further remediation activity, confirmation samples of clean overburden, boring log and well construction diagram with groundwater analytical results for piezometer installed. Operator also to submit Form 19 Supplemental Report with root cause and corrective action for flowline failure and resolution of Spill via Work proceeding under a Form 27. Operator to submit results of flowline repair pressure test on Form 19 Supplemental Report.
