COGCC Inspection Report Summary
On Thursday 7/29/21 at approximately 13:30 hours, I, Inspector Corey De Paolo, Conducted an on-site inspection at LARAMIE ENERGY LLC CC /0697-15-23 Pad, Location #335595 in Garfield County Colorado. While there, I observed normal production operations. During this inspection the following compliance issues were observed:

- 1) No battery sign located at the tank battery with a previous corrective action date of 9/29/21.
- 2) Unused equipment with a corrective action date of 8/5/21.
- 3) Multiple flow line heating insulation open ended and not capped with a corrective action date of 8/5/21.
- 4) Location lacks stabilization. No form of tracking BMP at entrance to location with a corrective action date of 8/13/21.

- Location is located in a high priority habitat area.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
