It was observed in this inspection that interim areas of the Location are not progressing towards COGCC 1003 Standards; interim areas predominantly bare soil, or dominated by cheatgrass; desirable vegetative germination and establishment is sparse and not uniform.

Corrective Action

Comply with COGCC 1003 rules; conduct additional revegetation activities on the interim areas of the Location. Comply with Rule 606 and monitor/manage location for weeds. Comply with 1002.f rules and implement control measures to stabilize the slopes and seeded soils. To allow for a fall seeding, a CA date of 11/15/2021 is being provided to complete reclamation work.
