General Comment:

I conducted a site inspection for Broomfield County complaint (#402775643) regarding a possible release from the oil storage tank on the Shannon - Roberts A-1 (05-014-08698) tank battery. The location is extremely weedy and it is obvious that no maintenance of the location is being conducted. An approximately 3 feet by 2 foot zone at the base of the oil tank (east side) is the release area. I dug down approximately 1 foot with a shovel and uncovered oil soaked soil (clay rich). Release at surface less than 1 BBL (based on visual observations). The oil tank is estimated to be 1/3 full of fluid. No other issues were observed other than lack of weed control and general site maintenance. See site photos.

The most recent field inspection (#693503696 [10/23/2020]) notes no response to previous corrective actions and that Natural Resources Group INC had filed for Chapter 7 bankruptcy on September 5, 2019.
