- The drainage crossing along the access road needs to be re-constructed and stabilized in a manner that supports adequate volumes of stormwater passage. It is evident that the culvert volume is not adequate to support stormwater flows in this area.</p> <p>Corrective Action: The drainage crossing along the access road needs to be re-constructed in a manner that supports adequate volumes of stormwater passage.
