Comment: There is still one abandoned pipe riser that remains along the road past any active well sites. The other risers observed further along the road were removed and disturbance was reclaimed. The disturbance areas will need to reestablish desirable vegetation cover. The remaining pipe riser needs to be removed. Ongoing monitoring and noxious weed control will need to be performed. Corrective action needs to be performed immediately.
