Comment:	<p>Two spills (480257&480867) are unresolved at the Razor 25P pad at the same flowline excavation, listed under Whiting Oil and Gas. Unresoved Remediation Project #20870 is open to complete the site investigation. Excavation remains open on location and confirmation soil sample results have not been received.</p> <p>Remediation of both spills has created additional impacts to vegetation east of the spill area and original location. Operator has opened new entrance to Razor 25P pad as a result of spill remediation interfering with original pad entrance.</p> <p>At least one flowline is cut/out of service and unsupported in excavation. Operator should contact Engineering Integrity Group for direction regarding repairs.</p>			
Corrective Action:	<p>Operator should submit Form 19 Supplemental for both open spills with root cause analysis on flowline failure.</p> <p>Operator should submit Form 27 Supplemental with analytical results or schedule for obtaining results.</p> <p>Operator should submit Form 27 Supplemental with reclamation plan for impacts to surface outside working pad surface.</p>			Date: 01/31/2022
