**Comment:** Operator has plugged and abandoned the well and is in process of abandoning the production equipment. Operator previously submitted a Form 27 Site Investigation Workplan which was returned to draft. Revised Form 27 has not been received.

No E&P Waste was observed stored onsite. Multiple pieces of equipment have been removed including: ASTs, Heater Treater, ECD, Gas Meter skid, and ancillary equipment.

Well has been cut & capped and excavation remains open.

**Corrective Action:** Form 27 must be resubmitted with a proposal indicating planned soil screening and soil sample locations, proposed soil sample analysis, and site map illustrating equipment locations and planned soil sample locations. Operator should refer to the to Rule 911.a.(4) - Oil and Gas Facility Closure Guidance Document and Rule 911.a.(4) checklists, as well as 915.e.(2) - Soil Sampling and Analysis Guidance Document. Operator shall include a schedule for sampling and followup reporting.

At a minimum samples for laboratory analysis are required adjacent the well at base of excavation, beneath former flowline risers, beneath heater treater, beneath AST footprint (beneath the liner once removed). Minimum required soil analysis includes the following Table 915-1 Contaminants of Concern: TPH (C6-C36), benzene, toluene, ethylbenzene, total xylenes, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene and soil suitability for reclamation parameters: electrical conductivity (EC), Sodium Adsorption Ratio (SAR), pH, and boron.

If impacts are observed Operator shall analyze soil samples for complete Table 915-1 Contaminants of Concern.

Corrective action date is date to resubmit Form 27 Workplan.
